Hello Readers,

The third week of July (July 14-18, 2025) is designated as Rural Road Safety Awareness Week (RRSAW). This focus this year is on post-crash care. Transportation practitioners at every level of the industry are called on to get the message out through a variety of social media, customizable news releases and proclamations to drive the effort to their locality.

What's so important about post-crash care? Post-crash care significantly impacts survival rates and reduces long-term disabilities after road traffic crashes. It involves providing timely emergency response and high-quality trauma care, creates a



safer environment for responders, and prevents secondary crashes. In rural areas, additional challenges exist due to longer response times and limited emergency medical services resources needed to make timely medical intervention.

The 2025 RRSAW has a catchy baseball theme designed to promote big league safety. Day 1 is "Hit a Grand Slam: Post-Crash Care on Rural Roads", Day 2 is "Assemble Your Dream Team: The Post-Crash Lineup", Day 3 is "Be a Pinch Hitter: Stop the Bleed, Save Lives", Day 4 is Change the Game: Extra Innings with Whole Blood", and Day 5 is "Come in Clutch: Relief Pitching for First Responders". Municipal Aid Applications Being Accepted for FY26 Grants

The Murphy Administration announced the grant solicitation period for NJDOT's Fiscal Year 2026 State Aid programs is now open. Starting today, April 25, applications will be accepted for Municipal Aid, Transit Village, Bikeway, and Safe Streets to Transit programs through July 1, 2025. NJDOT's grant cycles allow municipalities to incorporate awarded projects into upcoming municipal budgets to ensure that important infrastructure projects get to construction sooner. These efforts reflect NJDOT's commitment to using datadriven, next-generation solutions to improve roadway safety and efficiency across the state. On May 14, 2025, the NJDOT Bureau of Research, Innovation, and Information Transfer hosted a Lunchtime Tech Talk! webinar, "Research Showcase: Lunchtime Edition 2025", featuring four presentations on salient research studies. As these studies were not shared at the 26th Annual Research Showcase held in October 2024, the webinar provided an additional opportunity for the over 80 attendees from the New Jersey transportation community to explore the wide range of academic research initiatives underway across the state. NJDOT Issues New Bicycle and Pedestrian Micromobility Guide

The NJDOT Bicycle and Pedestrian Resource Center (NJDOT BPRC) has issued a Micromobility Guide for the Garden State, to help the public enjoy a safer and more accessible walking and cycling environment. The Guide summarizes state laws and best practices for safely riding, charging, and storing micromobility devices in New Jersey.

The Guide explains the regulations, characteristics, and transit agency rules for 11 types of micromobility devices, including traditional bikes, e-bikes, e-scooters, Segways, roller skates, and more. The Guide also clarifies how different classes of e-bikes are regulated under New Jersey laws. Key device features and regulatory differences are highlighted in easy-to-understand, one-page "cheat sheets" for each type of device.

Question #1

What points should I address when requesting a change order to help its chances of approval?

Assuming you have valid reason for a change order, there are four issues you should try to address when requesting a change from the oversight agency:

- 1. Why is the change necessary?
- 2. What will the impact be on the original scope of work?
- 3. Who is responsible for costs or delays?
- 4. Who should pay for the changes?

Keeping these things in mind at a minimum will be beneficial for any request.

Question #2

Is there anything I need to keep on hand to "prove" Buy America requirements are being met?

Any source documentation such as receipts and purchase orders should always be kept in your records. Contractors must also provide a signed certification statement regarding the manufacture of the iron and steel products to meet Buy America requirements.
