Making Safety Everyone's Business

Currently, the country faces a crisis on its roadways. In 2023, an estimated 40,990 people across the Nation—113 people per day—lost their lives in motor vehicle crashes. As a result, a key priority at the U.S. Department of Transportation and Federal Highway Administration is making the Nation's transportation system safe for all users. While FHWA and its Federal, State, local, and Tribal partner agencies have advanced the expertise of highway safety through HSIP, the funding available through it alone will not entirely achieve the goal of zero fatalities on the Nation's roadways—an ambitious, long-term goal.

In 2022, USDOT released the National Roadway Safety Strategy (NRSS), a comprehensive roadmap to significantly reduce severe injuries and deaths on highways, roads, and streets. The roadmap was an important step in working toward the elimination of roadway fatalities. As part of NRSS, USDOT adopted the Safe System Approach as the guiding paradigm to address roadway safety.

FY 2026 COUNTY AID



\$150 Million in County Aid Available

The Murphy Administration announced the release of \$150 million in Fiscal Year 2026 County Aid to fund infrastructure improvements on the local level. The program is funded through the New Jersey Transportation Trust Fund (TTF).

"Keeping our transportation infrastructure safe and reliable is among my Administration's top priorities," said Governor Phil Murphy. "These improvements will further our effort to make New Jersey's roads safer for every resident, in every community."

The State's 21 counties will share a total of \$150 million through the County Aid program that helps maintain roads and bridges under county jurisdiction in a state of good repair for the thousands of motorists that count on them each day.

Vision Zero Resources Online

Recently FHWA announced the launch of the FHWA Vision Zero Community of Practice (CoP) web page. The Vision Zero CoP offers a one-stop shop for technical resources and information that local communities can use to develop and implement safety efforts to reach their goal of zero roadway fatalities. FHWA supports the vision of zero deaths, including Vision Zero. The Vision Zero CoP is a component of FHWA technical assistance efforts to bring the latest resources to practitioners who have adopted or are considering adopting Vision Zero, applying the Safe System Approach, and growing a safety culture in their communities.

Work Zone Safety Clearinghouse

The National Work Zone Safety Information Clearinghouse is the world's largest online library of free information on work zone safety topics. It has grown significantly since 1995 when Congress directed its creation.

Originally conceived as an online library with a comprehensive listing of information and materials related to work zone safety, the Clearinghouse annually provides over 200,000 contractors and agency professionals with answers to work zone safety questions, from the most basic to the most advanced.

Much of the Clearinghouse's information stems from its original concept—a robust online database of several thousand papers, publications, books, brochures, videos, and interviews.

Question #1

What points should I address when requesting a change order to help its chances of approval?

Assuming you have valid reason for a change order, there are four issues you should try to address when requesting a change from the oversight agency:

- 1. Why is the change necessary?
- 2. What will the impact be on the original scope of work?
- 3. Who is responsible for costs or delays?
- 4. Who should pay for the changes?

Keeping these things in mind at a minimum will be beneficial for any request.

Question #2

What are the penalties for failing to comply with the DBE Contract Specifications?

DBE contract specifications are legally binding and must be enforced in the same fashion as any other contract requirement. Failure to carry out contract provisions may result in loss of Federal funds. The success of these programs is achieved by thoroughly implementing the monitoring and reporting procedures as the project progresses.
